5.1 WCF Terms of Reference

5.2 Insurance

- Adrian de Laborde (HDC) has confirmed with AMS that council insurance would cover any insurance issues that may arise regarding the hub.
- For any future WCF projects, the forum will assess the need for insurance at the time

5.3 OceanaGold update

Sponsorships and Donations

The 2023 year, saw OceanaGold donate funds to various Waihī organisations, including some funding to projects in Whangamatā, Whiritoa and the Westpac Helicopter. Donations totalled \$445,775.57 for the year.

Amenity Effects Programme

Now that all the data has been loaded and calculated, we will start progressing with new sign ups to the scheme and checks on residents to see if they are still at the same address. Once this work is completed, payments will go directly into qualifying residents bank accounts.

Waihī North Project

Requests for further information are still being worked through and progressed.

Crest Raise of TSF1

Work is ongoing on the crest raise of TSF1 (Tailings Storage Facility 1). This will increase the height of the facility by 1.4m. These works are due to be completed in April.

Education Centre Underground Simulation Visits

There was a lot of interest from locals along with tourists at these sessions, which ran over a week in the school holidays with 182 people attending.

6. STREETS AHEAD

Bank balance \$178,181.01 CR

- Tagged Funding (Hub) \$165,000
- Tagged Funding for Pit Rim Seating \$5,000

ACTION: BH to apply to the bank to cease deduction of resident withholding tax as per charity status.

ACTION: End of financial year, BH apply for return of deductions.

6.1 Outdoor Recreation Hub

- Rich Landscapes has provided concept plan.
- PB gathered up-to-date quotes from suppliers unable to get a formal quote from Rich Landscapes for the skate park, or HDC for their costs.
- PB to apply to Lottery Community Facilities Fund, round 2, \$1m, closing date 21
 February 2024. Next closing date not yet released, but last year round 1 was 6
 September 2023.
- PB applied for Lion Foundation funding of \$500k, but they will only consider funding if HDC apply for it, not WCF, as HDC will own the hub. Application

withdrawn. Lyn Randall HDC has confirmed HDC project Manager would be responsible for funding applications in this instance.

ACTION: BH to do Financial Statement for the Lotteries application
Action: PB to discuss fundraising with Ruth Vivian HDC

6.2 Bench seats around the pit rim.

- Sites are now chosen, seats to be fixed by bolts onto concrete supports suitable for moving in the future should they need to be (as advised by OceanaGold.)
- Quote received for "Rendezvous" bench seat with no back or arm rests from Streetscape (attached). With back and armrests will cost around \$2100 each.
- Quote from FB person received for \$1100 approximately per seat, with backs and arms (attached). The forum decided to get these ones. The Forum will pay for the seats, and OceanaGold (email from DF) have pledged to reimburse the Forum for two seats.

ACTION: KW to investigate OG installing seating

7. Any Other Business

- AMS gave an update in proposed line marking on basketball court.
- The Forum agreed to purchase 12 bath towels for use at the Waihī Community Marae on their "Kai and Shower nights" (Thursdays at 5.30pm). OceanaGold has asked the Forum to complete an application form for laundry costs.

ACTION - PB to complete OG application form for laundry costs and email to Donna.

ACTION - Purchase towels from Kmart and give them to the marae once ongoing laundry funding confirmed.
